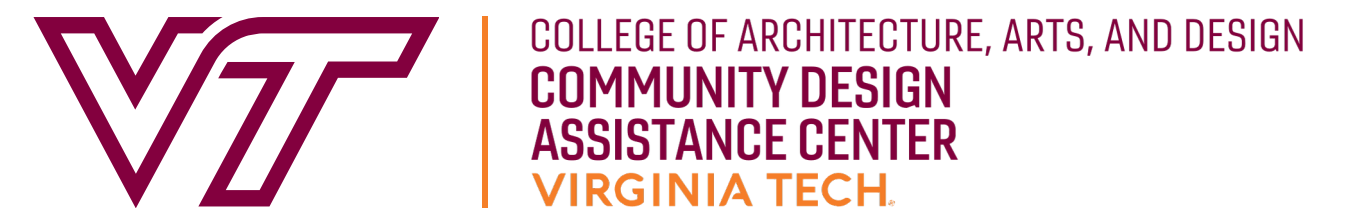
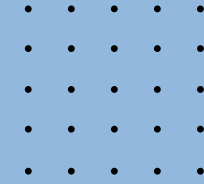
About Us

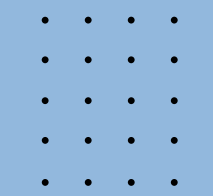

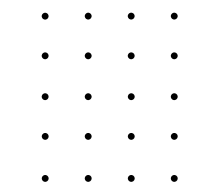

Multi-Purpose, Assessment, & Cleanup

* *RLF grants not offered FY26*

Eligibility- All Grants

- State, local and tribal government
- General purpose units of local government
- Regional council or redevelopment agencies
- Non-profit organizations*
- Quasi-governmental agencies

*501c4 organizations not eligible for Assessment, MP or RLF Grants but are for Cleanup Grants

These grants can be used to conduct/fund:

- ✓ Inventory
- ✓ General Planning Activities
- ✓ Site Assessment
- ✓ Community Involvement
- ✓ Site-Specific Cleanup Planning



TYPES OF ASSESSMENT GRANTS



Community Wide

Recommended for communities who are beginning to address brownfield issues as well as those who have ongoing efforts. Appropriate when a community has no identified specific site but plans to spend funds on more than one site in the community.

Coalition

Designed for one “lead” eligible entity to partner with 2+ other eligible entities. The lead member may submit one grant proposal under the names of the members and perform assessment grant activities in each coalition member’s community.

State and Tribal

Available to states, tribes, and eligible native corporations in Alaska to address brownfield sites throughout their entire jurisdiction.

Cleanup Grants

Uses and Considerations:

- Phase I/AAI required within 6 months or less prior to purchase
- Cleanup & remediation of 1 or more sites
- Typically limited to site-specific planning for cleanup site
- Applicants must have Phase II ESA or equivalent site investigation report(s) completed required prior to submission
- Site must be owned by the applicant at the time of the application

Multipurpose Grants

Best for communities that have identified a discrete area with one or more brownfield sites.

Range of activities, including:

- Developing prioritized inventories of brownfield sites;
- Conducting community engagement activities;
- Conducting environmental site assessments;
- Developing cleanup plans and reuse plans related to brownfield sites;
- Conducting cleanup activities on brownfield sites owned by the applicant; and
- Developing an overall plan for revitalization.

Extra Steps

Site for cleanup must be owned by the applicant by grant deadline

Verify timing of Phase 1 ESA/AAI and ownership transfer

Extra Steps for Cleanup Grants

- Verify timing of ownership transfer
- Community notification must:
 - Be published/posted at least 2 weeks before application submittal (not grant deadline)
 - Provide notice of public meeting (date/time) for grant application
 - Provide location of draft ABCA available for review
- Public meeting **must** be held before submitting application.

HOW TO PREPARE NOW

BEFORE FY26 GRANT GUIDELINES ARE RELEASED

New Application

- Start preparing draft application by referencing FY25 guidelines
 - Closed FY25 guidelines for reference
- Cleanup Grant: Contact state environmental agency for site characterization letter
 - Confirm eligibility of applicant
 - Verify timing of Phase 1 ESA/AAI (180 days or less)
- Familiarize yourself with previous guidelines, threshold criteria, and forms
- Make sure sam.gov and grants.gov accounts are up to date
- Reach out to EPA project officer before solicitations open
- Get to know your state environmental agency
- Contact Mid-Atlantic TAB with questions or to review draft

HOW TO PREPARE NOW BEFORE FY26 GRANT GUIDELINES ARE RELEASED

Revisions to FY25 Application (Unsuccessful)

- Review previous application to identify areas for improvement
- Refer to EPA debrief comments
- If no debrief, ask experienced reviewers (Mid-Atlantic TAB)
- Cleanup Grant: Contact state environmental agency for site characterization letter (cannot use previous year)
- Familiarize yourself with previous guidelines, threshold criteria, and forms
- Make sure sam.gov and grants.gov accounts are up to date
- Reach out to EPA project officer before solicitations open
- Reach out to your state environmental agency
- Contact Mid-Atlantic TAB with questions or to review draft

You will need:

- Unique Entity ID
- Tax ID #
- Bank routing number, bank account number, and account type (i.e. checking/savings) to set up Electronic Funds Transfer (EFT)
- All non-Federal entities must mail original, signed, and notarized letter to the Federal Service Desk within 30 days of activation.

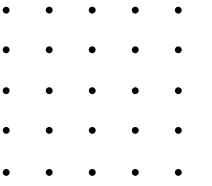


- Must be renewed every 12 months.
- Must be active when applying for grants.
- Make sure contact information is correct and up to date.
- FREE to register and renew- Watch Out for Scams!
