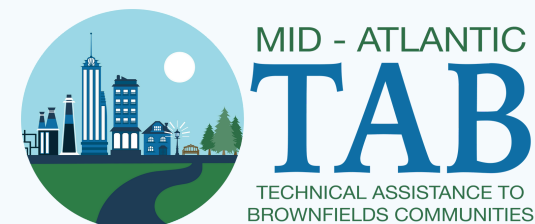

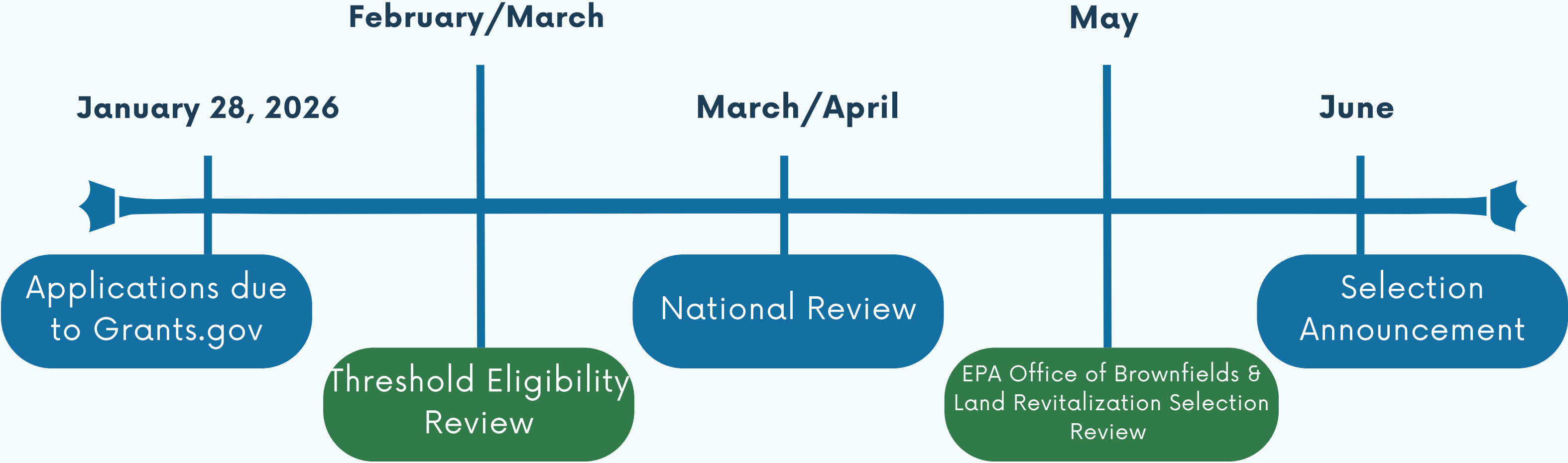

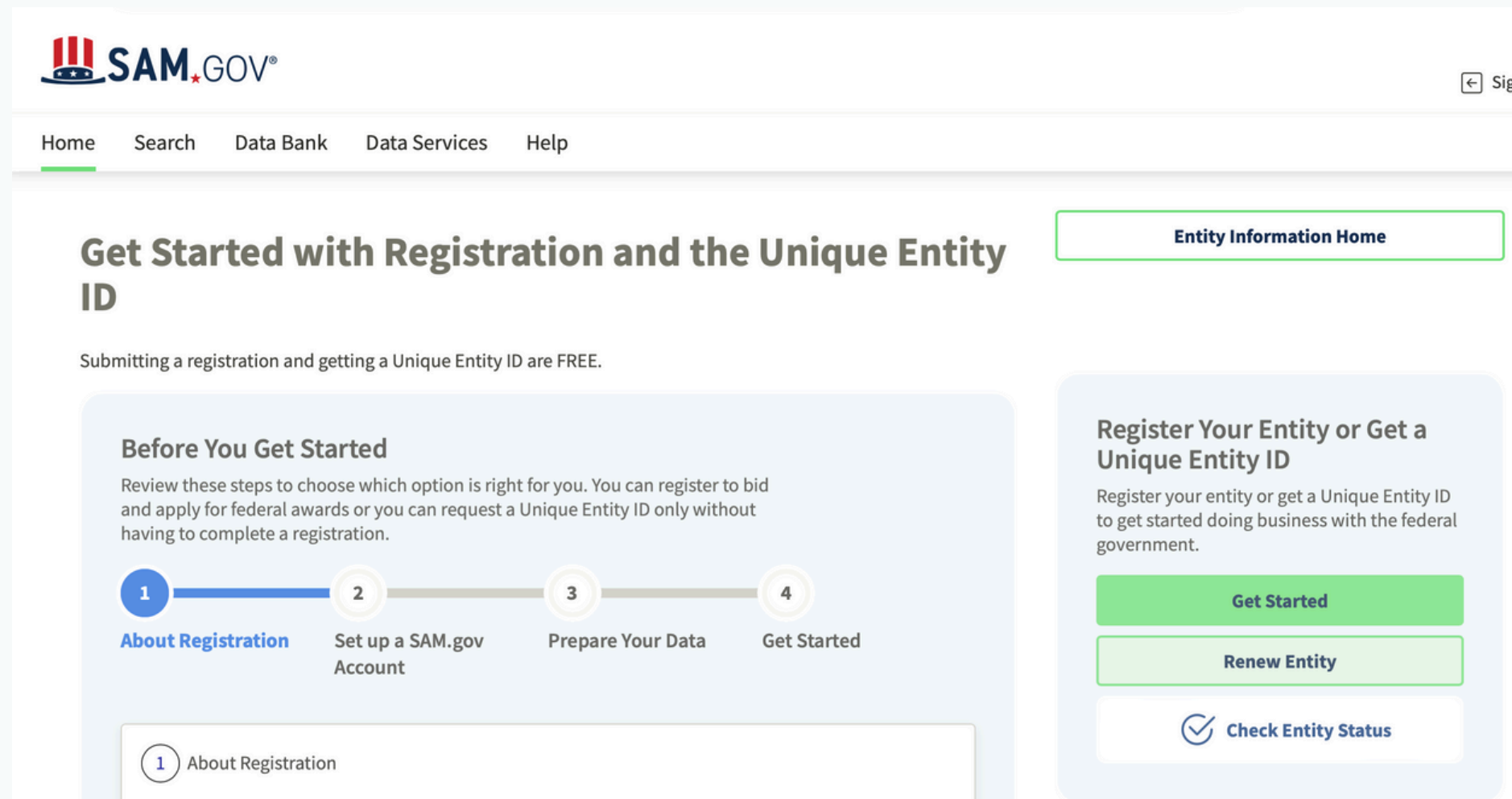

 - Register to do business with the U.S. Government
 - Update or renew your entity registration

 - Search for entity registration and exclusion records
 - Can take at least 2 weeks or more to complete- **Don't Wait!**

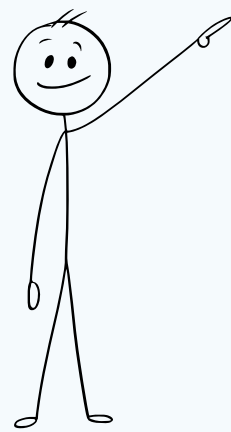
- ✓ Unique Entity ID (if not a first time registrant)
- ✓ Tax ID #
- ✓ Bank routing number, bank account number, and account type (i.e. checking/savings) to set up Electronic Funds Transfer (EFT)
- ✓ All non-Federal entities must mail original, signed, and notarized letter to the Federal Service Desk within 30 days of activation.

**DON'T!
FORGET!**

- Must be renewed every 12 months
- Must be active when applying for grants
- Make sure contact information is correct and up to date
- FREE to register and renew-
Watch Out for Scams!

PROCUREMENT **WARNING**

A qualified environmental professional (QEP) cannot prepare grant application AND be awarded contract to implement grant (Multipurpose, Assessment, RLF, Cleanup) **without going through competitive bid process**



This prevents the QEP from having an unfair competitive advantage



THRESHOLD CRITERIA HIGHLIGHTS



THRESHOLD CRITERIA

ALL Grants

- Threshold eligibility criteria ensure applicants are eligible to receive an EPA Brownfield MARC grant
- Criteria are pass/fail and based on certain requests for information identified in the following slides
- Information submitted is used by EPA only to make eligibility determinations for EPA Brownfield grants
- Only applications that pass **all threshold criteria** will be evaluated against evaluation criteria in Section 5.A. - Evaluation Criteria - of Grant Solicitations
- **Double check your work!!** You cannot make changes to your application past the submission deadline and EPA cannot accept additional documents past the deadline.

Responses to each criterion are required and must be included as an attachment to the grant Narrative which is included in application submitted to EPA.

Applicants deemed ineligible for funding consideration as a result of the threshold eligibility review will be notified within 15 calendar days of the ineligibility determination.



THRESHOLD CRITERIA

ALL Grants

Assessment/Multipurpose Grant

- Current letter from environmental state agency acknowledging that applicant plans to conduct activities and apply for FY26 brownfield grant
- Letter from previous year(s) not permitted

Cleanup Grant

- Current letter from environmental state agency acknowledging that applicant plans to conduct cleanup activities and apply for FY26 brownfield grant
- Site Characterization:
 - Determination must be made by the state environmental agency that either:
 - A sufficient level of characterization has been performed OR
 - Additional assessment is needed
 - If additional assessment is needed, a statement from the applicant confirming that sufficient characterization will be completed by June 15, 2026 must be included
- Phase II ESA completed (or equivalent)



THRESHOLD CRITERIA

Cleanup Grants Ownership Eligibility

- MUST be sole owner of the site at the time of application submission.
 - Fee simple title through a legal document.
 - The owner must have conducted all appropriate inquiries (AAI) prior to acquiring the property.
- Phase I Environmental Site Assessment not more than 180 days before the property transfer.
 - **The owner must not be liable in any way for the contamination at the site or affiliated with any other person potentially liable for the contamination.**



THRESHOLD CRITERIA

Cleanup Grants

COMMUNITY NOTIFICATION AND PUBLIC MEETING

PUBLIC MEETING

- Discuss the draft application
 - Consider public comments
 - Can be a regularly scheduled community meeting with other topics
 - In-person and/or virtual
- Required attachments for grant application:
 - Copy of newspaper/online advertisement of meeting
 - Comments or a summary of the public comments received
 - Response to public comments
 - Meeting notes or summary of public meeting(s)
 - Sign-in sheets or participant list



THRESHOLD CRITERIA

Cleanup Grants

COMMUNITY NOTIFICATION AND PUBLIC MEETING

COMMUNITY NOTIFICATION

- Ad in local newspaper or an equivalent means to communicate with target community.
 - **No later than two weeks before the application is submitted (January 14, 2026)**
- Must clearly state:
 - A copy of this grant application, including draft ABCA(s), is available for public review and comment
 - How to comment on the draft application
 - Where the draft is located (i.e. town hall, library, website)
 - Date, time, and location of public meeting(s)



THRESHOLD CRITERIA - INFOGRAPHIC

Cleanup Grant

Section A: Property Ownership Eligibility- Hazardous Substances

Liable parties may include all current and former owners and operators, and those who arranged for or contributed to the disposal and/or treatment of hazardous substances on the site. To be eligible for EPA grant funding, you must demonstrate that you:

1. Are exempt from CERCLA liability; or
2. The property is publicly owned and was acquired prior to January 11, 2002; or
3. Meet requirements for an affirmative defense to CERCLA liability

1. Exemptions to CERCLA Liability

- Indian Tribes
- Alaska Native Village Corporations and Alaska Native Regional Corporation
- Property acquired under certain circumstances by units of state and local government:
- Seizure or in connection with a law enforcement activity
- Bankruptcy
- Tax delinquency
- Abandonment
- Escheat or certain inter-governmental transfers
- See [FY2025 FAQs](#) for further information

The **Comprehensive Environmental Response, Compensation and Liability Act (CERCLA)**

imposes liability on parties responsible for, in whole or in part, the presence of hazardous substances at a site.

Info Needed!

To demonstrate (1) **the State or local government is exempt** OR To demonstrate (2) you qualify for the **Publicly-Owned Brownfields Sites exception** the following information is required:

- Conditions under which the property was acquired
- Date the property was acquired
- Whether all hazardous substance disposal occurred before your ownership
- Confirmation that you have not caused or contributed to the release of hazardous substances
- Confirmation that you have not arranged for the disposal of or transported hazardous substances to the property

2. Exceptions To Meeting the Requirements For Asserting an Affirmative Defense To CERCLA Liability

- **Publicly owned** brownfield sites acquired prior to January 11, 2002

THRESHOLD CRITERIA - INFOGRAPHIC

Assessment Grant

INFORMATION REQUIRED FOR ALL ASSESSMENT GRANTS

This covers the threshold eligibility criteria that ensure applicants can receive a grant. Threshold criteria are pass/fail and are based on the information below. Once you pass all threshold criteria, your application is evaluated further.

Applicant Eligibility

Indicate your applicant type and provide information that shows you are eligible for an Assessment Grant. Indicate if your organization is exempt from federal taxation.

Community Involvement

Provide information on how you plan to inform and involve the community in the assessment of your brownfield.

Contractors and Named Subrecipients

If you have selected a contractor, you must demonstrate that you did so according to EPA requirements. If you have identified a specific subrecipient, you must comply with EPA's subrecipient requirements even if they are referred to as a "partner" in your application.

Expenditure of Existing Grant Funds

If you have a pre-existing EPA Brownfields Grant, you must demonstrate that you have disbursed these funds.

Entities with an open Community-Wide Assessment Grant for States and Tribes (CWAGST) award (or a pending CWAGST award) must meet the 60.00% drawdown requirement for each CWAGST grant to apply for CWAGST funding under this solicitation.

Current Assessment & Multipurpose Grant recipients that want to apply for CWAGST funding must have met 70.00% drawdown requirement by [October 1, 2025](#) to apply for FY26 Community-Wide Assessment Grant.

Point/Percentage Distribution

- Project Area Description and Plan for Revitalization – 26%

Assessment Coalition Grants

Awards available up to \$1,500,000

Entities with open award (or pending an award for) Community-wide Assessment Grant for States and Tribes are not eligible to apply for Assessment Grant funding under this solicitation.

Previous limitations on entities eligible to lead Assessment Coalition Grant removed. List of entities eligible to apply for FY26 Assessment Coalition Grant is same for both lead and non-lead coalition members.

Current Assessment & Multipurpose Grant recipients that want to apply for funding must have met 70.00% drawdown requirement by October 1, 2025 to apply for FY26 Community-wide Assessment Grant.

Coalition target areas may not overlap, and the target areas must be in at least three (3) distinct municipalities or jurisdictions (e.g., town, city, or Tribe).

Cleanup Grants

Applicant site characterization

If additional assessment is needed to “sufficiently characterize the site(s) for the remediation work to begin”:

- a statement must be included confirming that additional assessment will need to be performed AND
- affirm that a sufficient level of site characterization will be performed **by June 15, 2026** to allow for remediation work to begin.

This is in addition to required state environmental agency letter for Cleanup Grant applications

NEW CHANGES

Cleanup Grants

If your site is eligible to enroll in your state VRP/VCP:

- Letter from State Environmental Authority must indicate whether the site(s) is enrolled or intends to be enrolled in state or Tribal voluntary response program for oversight (Site Characterization, Section B(9)b. of Threshold Criteria requirements in NOFO)

Grant budget can include costs for state VRP/VCP process!

All Narratives must be single-spaced. Nothing exceeding page limit will be reviewed.

- Cleanup/Assessment Grant: 10 page limit
- Multipurpose Grant: 12 page limit
- The Narrative, which includes responses to the ranking criteria, must provide sufficient detail to allow for an evaluation of the merits of the application.
 - i. Project Description and Plan for Revitalization
 - ii. Community Need and Community Engagement
 - iii. Task Descriptions, cost estimates, and measuring progress
 - iv. Programmatic Capability and Past Performance
- Threshold Criteria Responses
- Other Factors and Considerations
- **Note:** EPA only evaluates the information that is requested and required in the NOFO. Therefore, we do not encourage applicants to solicit support letters from members of Congress or include such letters with their applications.

STATE-SPECIFIC THRESHOLD CRITERIA

Cleanup & Multipurpose Grants



If eligible for Brownfield Program:

- THE APPLICANT MUST AFFIRMATIVELY DEMONSTRATE THEY DID NOT CAUSE OR CONTRIBUTE TO THE RELEASE
- THE APPLICANT MUST BE IN FULL COMPLIANCE WITH ALL ENVIRONMENTAL REQUIREMENTS IN DELAWARE
- MUST NOT BE A CHRONIC VIOLATOR
- MUST NOT BE IN ANY CURRENT ENFORCEMENT ACTION WITH A STATE OR A FEDERAL ENVIRONMENTAL AGENCY

If **NOT** eligible for Brownfield Program:

- THE APPLICANT IS A RESPONSIBLE PARTY
- THE APPLICANT IS NOT IN COMPLIANCE WITH ALL ENVIRONMENTAL REQUIREMENTS IN DELAWARE
- IS A CHRONIC VIOLATOR
- IS IN A CURRENT ENFORCEMENT ACTION WITH A STATE OR A FEDERAL ENVIRONMENTAL AGENCY

DNREC REVIEW

- DNREC must review assessment results
- State letter must affirm eligibility for the site to be entered into the Delaware Brownfield Program
- Letter must also affirm that the site either has a sufficient level of site characterization to begin remediation or will require additional assessment/site characterization to begin remediation
- For sites not eligible for the Brownfield Program (e.g., asbestos), an Environmental Professional must certify that a sufficient level of site characterization has been performed in order to begin remediation OR that additional assessment needs to be completed
- Please submit your request to DNREC as soon as possible so that DNREC has sufficient time to review assessment data!



LETTER FROM DNREC

- Required attachment for all grants
- Acknowledges state's awareness and support of the project(s)
- Site Characteristic level from ESA
- One letter can be used for multiple applications
- Letter must be current (cannot use previous year's letter)
- Contact for State Letter:
 - DNREC
 - Melissa.Leckie@delaware.gov
- Request should:
 - Include the grant applying for, location, and the plan for the site/project.
 - Please submit your request to DNREC as soon as possible with at least a 2-week notice before your expected submission timeframe

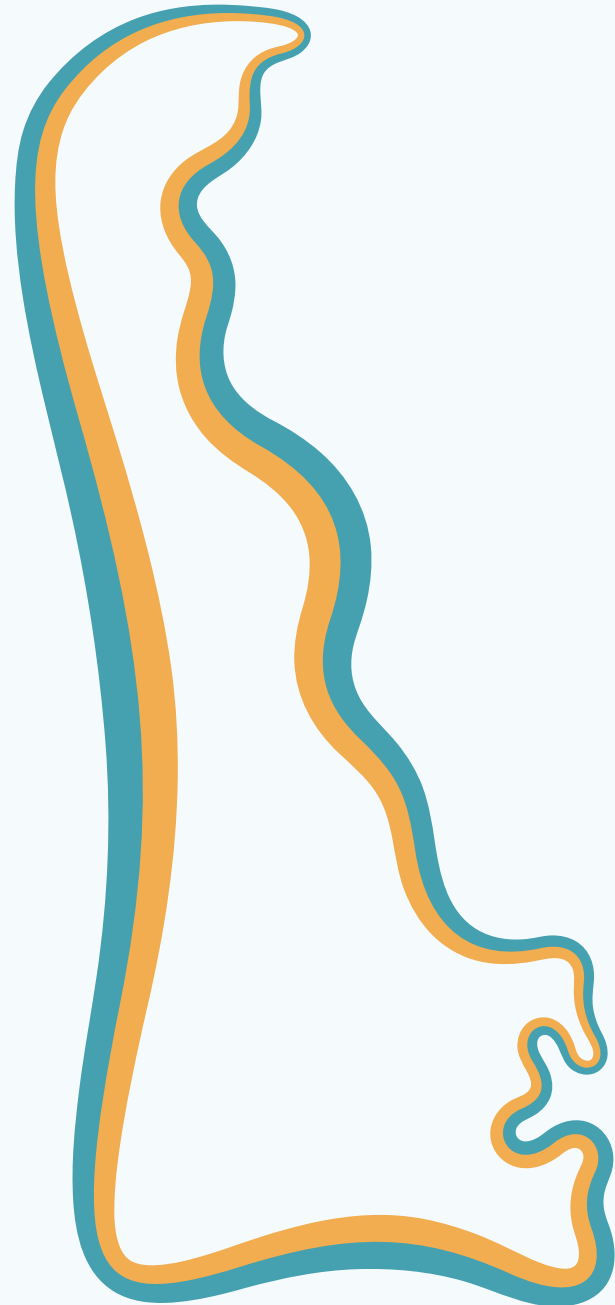

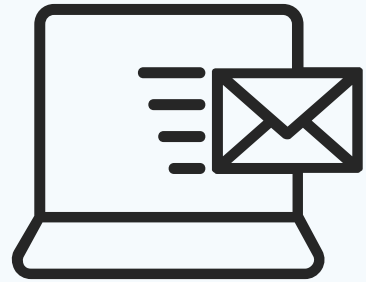

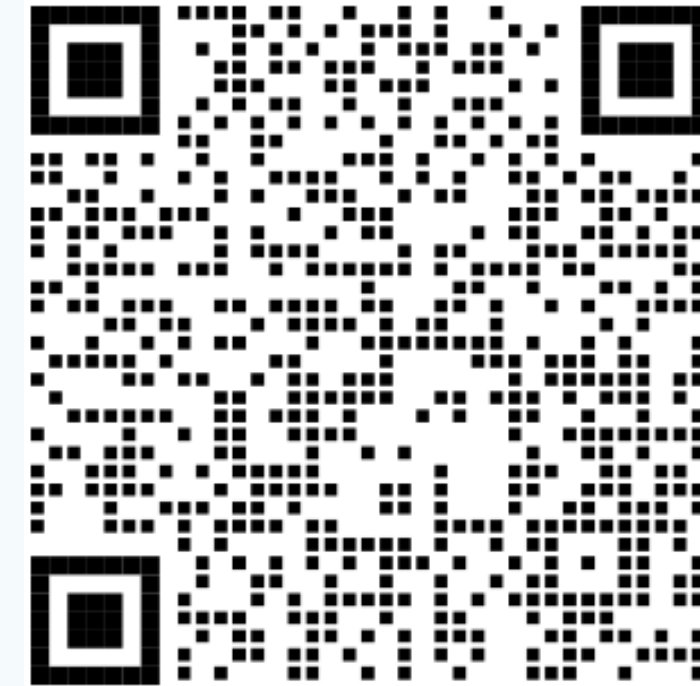
